

## COMPOSITION OF THE COMMISSIONS OF THE INTERNATIONAL OLYMPIC COMMITTEE

We thought it might be helpful to remind you of the composition of the Commissions of the International Olympic Committee. In this list the two Cultural and Legislation Commissions are mentioned, which were created as a result of decisions taken during the 67th Session of the International Olympic Committee in Mexico.

Furthermore, we are publishing the composition of the five joint IOC/NOC Commissions, as fixed at the end of the Mexico Session and which are responsible for re-examining all the questions concerning or in any way connected with the National Olympic Committees. Each of these Commissions consists of six International Olympic Committee members and six National Olympic Committee members. One of the latter assumes the chairmanship and holds a casting vote.

General José de CLARK, vice-president of the IOC on the one hand, and both Mr. Constantin ANDRIANOV vice-president of the IOC and Syed WAJID ALI member of the Executive Board on the other hand, have agreed to be responsible for the presidency and the vice-presidencies respectively of the Co-ordinating and Supervising Committee for IOC/NOC Relations.
