

The new Commissions of the IOC

At the meeting of the Executive Board, the position of all Commissions was reviewed, and the following are the approved recommendations.

The last paragraph of rule 13 has been deleted according to the amendment sheet distributed to all members.

The Vice-Presidents are ex-officio members of all Commissions. The Director and/or the Technical Director attend all meetings under their respective responsibilities.

● Finance Commission

President: Comte Jean de Beaumont.

Members: Me Marc Hodler, the Lord Luke.

It is empowered to seek the advice of any member of the International Olympic Committee which can assist it, as well as that of the International Federations or of specialised persons. Its main function will be:

- a) budget;
- b) control of finances – both income and expenditure;
- c) terms of employment and salaries of staff;
- d) preliminary negotiations with Organising Committees of the Olympic cities for television rights.

● Information and Culture Commission

This commission will be presided over by the President of the IOC or a Vice-President.

This commission will normally only meet in full at sessions, but will work in sub-committees for press, publications, culture, radio and television.

This commission replaces the Legislation Commission, and is responsible for the co-ordination of the French and English rules, remembering that the French language takes precedence. It will also be responsible for checking that the rule book is kept up to date and amended.
