

# Secretary-Treasurer's Report

## STATEMENT REGARDING THE FINANCIAL SITUATION

Revenues slightly exceeded expenditures in the North American Society for Sport History in 1983, This was due principally to an increase of 50 individual and institutional members and stability in the cost of publications. We can anticipate a slight loss in 1984 as we change editorship and location of the publisher of the JOURNAL OF SPORT HISTORY. In addition, the distribution of the Directory of Scholars for the first time since 1979 will contribute to an increase in expenditures. Nevertheless, NASSH continues to be financially stable with a comfortable reserve fund invested at nearly 10% interest.
